The intention is to provide some guidance for you to understand the nature of the risks and potential reward of the product and decide whether the product is right for you.

This investment may be right for you if: -

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you;**
- You are looking for **income paid semiannually**, linked to the performance of the **underlying assets**;
- You understand that on a quarterly basis, you will receive a coupon, subject to the referenced entities not experiencing a credit event. However, if a credit event occurs, no coupon is paid and you may lose some, or all of your capital;
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you may receive cash at the equivalent amount to the worst performing asset;**
