

The risk indicator assumes you keep the product until 8 December 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. We have classified this product as 6 out of 7, which is the second-highest risk class.
