#### WHAT IS THIS PRODUCT?

TYPE The product is in the form of a debt instrument, governed by English law.

#### **OBJECTIVES**

To provide interest payment(s), in return for the risk of loss of capital. Amounts stated below are in respect of each Nominal Amount that you invest.

- Interest (including memory feature): If the Worst Underlying Performance is greater than or equal to 0%, on any Interest Valuation Date, You will receive the Interest Amount 1 on the immediately following Payment Date. #### Early redemption and adjustments

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

#### SUMMARY RISK INDICATOR





The risk indicator assumes you keep the product until 26 February 2024. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because BCS is not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. This classification takes into consideration two elements: 1) the market risk - that rates the potential losses from future performance at a very high level; and 2) the credit risk which estimates that poor market conditions will likely impact the capacity of Brokercreditservice Structured Products Plc to pay you. A risk that is materially relevant to the product but not included in the summary risk indicator is the risk that in the event the product redeems early due to an autocall, early call, you may be unable to reinvest your money at an attractive rate.
